On careful consideration of the proposal the Government of Telangana has decided to issue an essentiality certificate to the applicant for establishment of a Medical College under the name and style of "CMR Institute of Medical Sciences" at Kandlakoya (V), Medchal (M), Medchal-Malkajgiri District with an intake of 150 seats per annum in MBBS course for the academic year 2022-23.

It is certified that:-

- a) The applicant owns and manages a 330 bedded Hospital for 2 years which was established in 2016.
- b) Essentiality certificate should be valid for three academic years (2022-23, 2023-24 & 2024-2025)
- c) It is desirable to establish a medical college in the public interest;
- d) Establishment of a medical college at Kandlakoya (V), Medchal (M), Hyderabad, Medchal-Malkajgiri (D), Telangana – 501401 by CMR Technical Education Society, Secunderabad is feasible.

- e) Adequate clinical material as per the National Medical Commission norms is available.
- f) The CMR Technical Education Society, Secunderabad own and possesses Ac.10-34.83 gts of land in Kandlakoya (V), Medchal (M), Hyderabad, Medchal-Malkajgiri (D), Telangana, on which non agricultural use of land is permitted and a Medical College / Hospital can be established on it.
- g) The building plan of the Hospital and Medical College has been approved by the competent authority, namely, Gram Panchayat Kandlakoya Village, Medchal Mandal, Medchal-Malkajgiri District, Telangana designated by the State Government for such purposes on 08.12.2008 (Copy of the approval is enclosed).
- h) The High Power Committee has recommended to issuance of Essentiality Certificate/ No Objection Certificate in respect of CMR Technical Education Society, Secunderabad for establishment of Medical College with an intake capacity of 150 seats per annum in the MBBS Course, subject to applicant providing all the required infrastructure for the benefit of students in all respects before admission process in undertaken).

Conditions (e) (f) and (g) are applicable only for non-governmental applicants.

It is further certified that in case the applicant fails to create infrastructure for the medical college as per NMC norms and fresh admissions are stopped by the National Medical Commission, that State Government shall take over the responsibility of the students already admitted in the College with the permission of the National Medical Commission.
